- 3. Each application must be accompanied with a short essay outlining your career goals, aspirations, and work experience. Describe your connection with the union and labor movement. Explain why you are a good choice for a union scholarship.
- 4. The scholarship shall be applicable solely for an accredited college or accredited post-high school educational program.
- 5. The recipient of the scholarship must be enrolled at an accredited college or accredited post-high school educational program.
- 6. The scholarship will be granted for one academic year.
- 7. The scholarship will be available to both full and part time students.
- 8. The scholarship committee shall recommend recipients for the award based on merit, which will be determined by scholastic ability or its equivalent. Consideration of financial need will enter only under extraordinary circumstances.
- 9. All applications must be sent by US Mail and must be received by April 11, 2020.

The scholarships to be awarded are in the amount of \$1,000.00. Four will be awarded. Only the recipients will be notified.
